REVISED 2023 RULES of GOLF - BRIEF SUMMARY and OVERVIEW

- Modified rules for players with disabilities has been incorporated into the Rule [Rule: 25]
- The Interpretations (2019) are now called <u>Clarifications</u>
- New added Clarifications are called Additional Clarifications
- The penalty for playing an incorrectly substituted ball is now **1 penalty stroke** [Rule: <u>6.3b(3)</u>]
- A player may repair or replace a damaged club unless the damage was caused by abuse [Rule: 4.1a(2)]
- After a ball is dropped or replaced and is moved by natural forces into another area of the course, the ball is replaced without penalty [Rule: 9.3 Exception 2]
 Note: Includes a ball moved (by natural forces) out of bounds
- When taking back-on-the-line relief the player **must** drop the ball **on the line** [Rule: <u>14.3b(3)</u>] *and*
- When taking back-on-the-line relief the dropped ball may roll 1 club-length in **any direction (including forward)** after hitting the ground [Rules: <u>16.1c(2)</u>, <u>17.1d(2)</u>, <u>19.2b</u>]
- When a ball played from the putting green hits the player, the player's putter, or an insect (or similar) the stroke counts [Rule: <u>11.1b(2)</u>]
- If a player fails to replay a stroke when required, the penalty is the general penalty **not** a wrong place penalty which could be subject to disqualification [Rules: <u>11.1b</u>, <u>11.2c</u> and Definition: <u>Wrong Place</u>]
- When there is not a spot in the general area immediately **behind** an embedded ball to use as a reference point for taking relief, the player may find a reference point at the nearest location (no closer to the hole) in the general area [Clarification: <u>16.3b/1</u>]
- The Committee (not the player) is responsible for including the player's handicap on the player's scorecard [3.3b(4)]
 Note: a MLR may be introduced to place responsibility with the player [MLR L-2]
- A player is not allowed to set anything down on the course to assist in determining the line of play, even if the object is lifted prior to the stroke [Rules: <u>10.2b(1)</u> and <u>10.2b(2)</u>]
- When multiple penalties occur (including different penalties), a player is only penalised for the larger of the multiple penalties **unless** an intervening event takes place (a stroke or the player becomes aware of **the breach**) [Rule: <u>1.3c(4)</u>]
- A player is disqualified for giving any information to an opponent which results in a player getting too few strokes or giving too many strokes [Clarification: <u>3.2c(1)/2</u>]
- Multiple markers do not need to certify the hole scores on the scorecard if one marker sees the player play all of the holes [Rule: <u>3.3b(1)</u>]
- After a round has commenced, a player is permitted to remove an external attachment on a club without penalty, **provided the club has not been used for a stroke that counts** [Rule: <u>4.1a(3)</u>]
- A player must not build a club from parts carried **by anyone** on the course [Rule: <u>4.1b(4)</u>]
- The limitations on green reading material only applies to strokes made on the putting green [Clarification: <u>4.3a/1</u>]
- A player is allowed to practice on any holes **not** being played on the day of the competition [Clarification: <u>5.2/1</u>]



- If players **agree** to play out of turn to gain an advantage, **those players** are penalised (General Penalty) **if one of the players makes a stroke out of turn** [Rule: <u>6.4b(1)</u>]
- The conditions affecting the stroke that are worsened by a referee may be restored [Rule: 8.1d(2)]
- The area behind the player while the player is taking their stance is referred to as the "**Restricted Area**" [Rule: <u>10.2b(4)]</u>
- A player's caddie may stand in the "**Restricted Area**" prior to the player making their stroke if they are not assisting the player with aim [Rule: <u>10.2b(4)</u>]
- A player is not allowed to set a self-standing putter down to help with alignment. This change has been **delayed** until January 2025 [Clarifications: <u>10.2b/1</u> and <u>10.2b(3)/2</u>]
- When attempting to correct playing from a wrong place, a player is only required to report the facts to the Committee when the player plays 2 balls [Rule: <u>14.7b(2)</u>]
- An additional minute is the amount of time a player has to identify their ball after it has been found within **and** close to the 3 minute search time allowed [Clarification: <u>18.2a(1)/3</u>].

IMPORTANT MODEL LOCAL RULE CHANGES

- When a player does not replay a stroke that hits a power line, the stroke counts and the player gets the general penalty [MLR E-11]
- The Committee may allow relief from immovable obstructions in a penalty area [MLR F-24]
- The penalty for a breach of the one-ball rule is 1 stroke (was 2 strokes) [MLR G-4]
- The Committee may restrict the damage to a club before it can be replaced [MLR G-9]
- The Committee can prohibit the use of green reading material on the putting green [MLR G-12]
- The Committee can prohibit practice on practice putting greens [MLR I-1]
- Bad times can be carried over to subsequent rounds in stroke play competition [MLR K-2]
- The Committee may modify the penalty for a non-certified score card to 2 penalty strokes rather than a disqualification [MLR L-1].
